Application

1. No person shall be admitted into membership of the Society unless they have attained the age of 16
2. An application for membership must be approved by a majority of Directors voting in a meeting of Directors at which applications are being considered. The Directors have an absolute right to reject an application without providing an explanation for so doing

Objects of The Society

1. The Society's objects shall be the promotion for the benefit of the public and the local community of rural regeneration in areas of social and economic deprivation or housing need (and in particular in the Parish of Above Derwent in the Borough of Allerdale, Cumbria) by the provision and management of housing stock (including social housing) and the provision of housing for those who are in conditions of need and as ancillary to this main object and as may be thought fit and where the activities of the Society may reasonably allow the:
 - a. Improvement of housing in the public sector or in charitable ownership provided that such power shall not extend to relieving local authorities or other bodies of a statutory duty to provide or improve housing
 - b. Provision of associated facilities, amenities, services and recreational facilities for the public at large or for those who by reason of their youth, age, infirmity or disablement, financial hardship or social and economic circumstances have need of such facilities
 - c. Relief of financial hardship
 - d. Provision of workspace buildings and/or land on favourable terms and/or the provision of financial assistance, technical assistance, business advice or consultancy to existing businesses or to persons wishing to set up new businesses
